4. Trot - 3 Year Old Filly Stake - OFRCClosed
5. Pace - George "Tom" Criswell Pace - Free For All - \$50 Entry Fee Added - Limited to eight (8) entries with no trainer having more than one (1) entry. If more than eight (8) horses are entered, Ohio sired or Ohio owned will have first preference and the top money winners in 2018 will have second preference.Added \$1,800

TUESDAY, JULY 3, 2018 - POST TIME 11:00 A.M.

6. Pace - 2 Year Old Colt Stake - OFRCClosed
7. Trot - 2 Year Old Colt Stake - OFRCClosed
8. Pace - 3 Year Old Colt Stake - OFRCClosed
9. Trot - 3 Year Old Colt Stake - OFRCClosed
10. Trot - "Big Jon" Townsend Trot - Free For All - \$50 Entry Fee Added - Limited to eight (8) entries with no trainer having more than one (1) entry. If more than eight (8) horses are entered, Ohio sired or Ohio owned will have first preference and the top money winners in 2018 will have second preference.Added \$1,800

CONDITIONS

1. Entry Fee: \$50 for overnight events; \$75 for stakes races.
2. USTA Rules to govern with exceptions. Money will be divided 50% - 25% - 12% - 8% - 5%. Declaration to be made by 10:00 A.M., THREE (3) DAYS before race. Five to enter in overnight or no race. Once a horse is entered, there will be no return of entrance fee unless program is rained out. Track will score 6 wide. One heat plan. Current Coggins Test required.
3. All owners must have 2018 Ohio State Racing Commission license or any winnings will be withheld until blood test comes back negative from the Ohio Department of Agriculture (approximately 3-4 weeks).
4. Management reserves the right to change order of program, postpone or declare off races or refuse to accept any entry. Accidents, injuries, damages, or losses that occur on the grounds, to people or property, sustained or caused by any horse, its owner or driver and/or their employees, agents, helpers, shall be assumed by them in full as their own risk and responsibility, individually and severally.
5. Colt Stakes governed by Ohio Fair Fund, USTA and Ohio State Racing Commission Rules. Colt Races subject to cancellation if state money not received.
6. No more monies will be paid than there are starters in any overnight event.
